DEMOGRAPHICS OF IRUMA

Foreign Residents Account for 1.4 % of Iruma's Population

foreign residents who have registered in Iruma City, which is an increase of two hundred from the previous year (1,899), and again surpassed all previous records. The total population of Iruma has been on a gradual downward trend, and in the same period it decreased from 148,723 to 148,442. Consequently, the proportion of foreign residents is rising. The data on the number of people by country is no more available due to the change of registration system in 2018.

In accordance with the projected amendment of the Immigration Law in April, we expect more people to come to Japan. The City of Iruma and the Iruma International Friendship Society are examining how we can enhance the service for foreign residents.

Special Exhibition at The City Museum Life and Tools in Olden Days

READY TO FILE YOUR FINAL TAX RETURN?

Tax returns for the year 2018 should be submitted by March 15, 2019. If you are a regular employee, your company may have already adjusted all tax payments for you through the process of the year-end adjustment (年末調整 'nenmatsu chosei'). However, if you think you missed the adjustment, or if you have any other tax deductions such as a large amount of medical expenses and housing loan, you should file your final tax return (確定申告'kakutei

You can submit your final tax return form at the City Office from the middle of this month to March 15. The service is also available on Sundays of February 24 and March 3. It is essential to bring all documents relating to your income e.g., your certificate of withholding tax (源泉徵収票 gensen choshu hyo), certificate of payment of insurance premiums, receipts issued by medical institutions (if any).

Please be advised that for overseas dependents tax exemption, you need documents to prove family relationship (e.g. birth certificates) with a Japanese translation and a document to prove remittance with names of the remitter and the receiver and the amount and date of remittance. You also need 'MY NUMBER' to file the tax return. As for the deduction for Kominkans; hours are 9:00 a.m. to 3:30 housing loans, which cannot be handled by the City Office, $\,$ p.m. *For Nihongi Kominkan, 9:00 a.m. you need to go to Tokorozawa Taxation Office. NEW PLAN TO IMPROVE EARTHQUAKE RESISTANCE OF CITY OFFICE AND SHIMIN HALL

Iruma City has been addressing the issues of earthquake resistance of public facilities, and completed seismic retrofitting for all the elementary and junior high public school facilities and the Shimin Gym. As for the City Office (A and B bulidings) and the Shimin Kaikan Hall, both of which are aged over 40 years, a plan to reconstruct them to make one multi-functional building was proposed last year. However, based on citizen's opinions against the idea, mainly in concern about the lack of parking space, the City made a new plan for these two facilities.

RECONSTRUCTION OF CITY OFFICE AND RENOVATION OF SHIMIN HALL

In the new plan, a new building will be built on the current premise of the City Office and after the functions in the A and B buildings are moved, these two old building will be demolished. The C building of the City Office was constructed in 1990 in accordance with the new quake-resistance standards, so it will be maintained. A new exit of parking lot will be set up on the north side of the premise to address the current traffic whirlpool at the front gate. As for the Shimin Kaikan Hall, the plan proposes its major renovation for earthquake resistance. It was found that reconstruction of the big building on the current premise is impossible because the area is designated to a most strict Class One low-rise building area. If the estimated cost of renovation is found to be too big, a new hall will be build on a new place or some other feasible plan will be made. In either case, the Hall will be closed after the renovation of the Sangyo Bunka Center is completed in 2020, because the current Hall building is not safe for public use.
