TO SUPPORT LOW-INCOME HOUSEHOLDS SPECIAL BENEFIT OF 70,000 YEN PAID THIS MONTH

To mitigate the impacts caused by recent utility cost increases, the city will offer a special one-time benefit of 70,000 yen to low-income households who have a resident registration in Iruma as of December 1, 2023 and whose per capita levy of local resident taxes are exempted for all the household members. Eligible households should have already received a notice of payment by postal mail. No reply or application is necessary. The benefit will be automatically sent to your registered bank account after the middle of February.

If you think you are eligible but have not received any notice, there is a possibility that the City cannot monitor your income in 2022 because you failed to report your income through your company or by yourself. In this case, contact the Seikatsu Shien-ka.

Also, if you did not have any resident registration in Japan as of January 1, 2024 (i.e. you entered Japan late 2023 or early this year), you need to make an application to receive this benefit. Apply at the City Hall or City Branch Offices with your passport, resident card and cash card/bank book. Inquiries: Seikatsu Shien-ka (Section for Livelihood Support)

RATE OF FOREIGN NATIONALS EXCEEDED TWO PERCENT IN IRUMA

As of January 1, 2024, there are 2,958 foreign residents who have registered in Iruma City, which still shows a continuous increase after COVID ban was lifted. Residents from other Asian countries are dramatically increasing; among them the population of Indonesian increased by 50% compared to the previous year. While the total population of Iruma has been on a continuous downward trend, the proportion of foreign residents is as high as **2.04%** as of January 1, 2024; one out of 50 Iruma citizens is a foreign national!

TIME TO FILE YOUR FINAL TAX RETURNS

Tax returns for the year 2023 should be filed by March 15 (Fri). If you have gone through the year-

end adjustment (nenmatsu chosei) procedures by your company, you do not have to worry about the final tax return, except when you have any deductible expenses not reported to the company such as dependents overseas, a large medical expenses and housing loan.

The Information Desk is happy to help you with your processing. Just bring all the related documents, including the gensen choshu hyo, a certificate of life insurance premium payment, receipts of medical expense, etc. Also, Tokorozawa Taxation Office (Tokorozawa-shi Namiki 1-7) consultation tables on weekdays from February 16 to March 15 and on February 25 (Sun), from 8:30 a.m. to 4:00 p.m.. You can pick up an appointment number by Taxation Office's official LINE account or on the day. Because one case takes a quite long time to complete, please allow enough time for consultations.

NATIONAL HEALTH INSURANCE PREMIUM INCREASE FOR FY 2024



In accordance with the Prefectural policy for the operation of the National Health Insurance (NHI) scheme, cities in Saitama need to resolve any debt in the NHI account and adopt the integrated premium rates by 2026. The City of Iruma revises the premium rate.

The City will start applying the new premium rates in April 2024. The premium on per capita basis (computed evenly according to the number of family members) will be increased from 43,000 yen to 67,000 yen a year (total of medical benefit/kaigo/support for elderly), with minor changes in the rate of the income-based premiums.

The City will strengthen its efforts to reduce medical expenses (e.g. promotion of generic drugs and health promoting programs) and increase income (e.g. collection of unpaid premiums).
