LEARN HOW YOUR CITY TAX WAS USED CITY FINANCIAL RESULTS FOR FY 2024 PUBLISHED

Iruma City has closed its books for the 2024 fiscal year which ended on March 31, 2025. In the general account, the overall revenue came in at 52,847 million yen, which is a 7.2% increase from the previous year. The expenditure also increased by 6.5% to 51,233 million yen.

¥148,105 IN vs. ¥358,571 OUT per capita

Municipal taxes contributed 21,161 million yen (40.04% of the total revenue) which equates to 148,105 yen per capita, while the expenditure per capita was about 358,571 yen. The difference is mostly covered by the subsidies from the national governments and loans. The fiscal adjustment fund (savings of the city) decreased by 390 million yen from the end of the 2023 fiscal year, resulting in a balance of 3,542.8 million at the end of the 2024 fiscal vear.

Highlights of the expenses

Among the strategic expenses of the city are the New Industrial Land Creation Project around Ome Interchange and the Commercial Promotion Project for revitalizing shopping districts. The city spent 79 million yen and 36 million yen respectively. The City also used 39 million yen for the Playground Equipment Installation Project and 16 million yen for the Learning Support Program for Children from Single-parent Families.

We are still in a healthy financial state

There are several barometers for the health of municipal finance. For Iruma, we have good results in all, including the ratio of the budget deficit, the ratio of the burden for the future and the funding gap for public-service companies. Inquiries: Zaisei-ka (Financial Section)

IRUMA'S AFTER-SCHOOL CARE SERVICES "GAKUDO" TO BE CHANGED


Applications for children wishing to enroll from April 2026 are accepted on November 7 (Fri) at the Seishonen-ka with documents, while applications through LINE are accepted until November 9 (Sun) (use the QR code on the right).

The city announced that after-school care fees, which are currently 7,000 yen a month per child, will be revised to be 10,000 yen a month starting in April 2026. Instead, extended hours and school holiday surcharges will be

> abolished. Also, for the second child in a household enrolled in a public after-school care facility, the fee will

be 5,000 yen, and for the third child and beyond, the fee will be 0 yen.

National Health Insurance (NHI) is a system for those who are not employed, in which all members support each other so that they can receive affordable medical care when they become ill or injured. However, because revenues are low relative to necessary

expenditures, the system is in the red, resulting in the situation where funds are being transferred from the general account to cover the

DID YOU GET "NENMATSU CHOSEI" YEAR-END ADJUSTMENT?

The Information Desk receives inquiries about the papers. This is a part of procedures called year-end adjustment (年末調整 'nenmatsu chosei') to allow your employer to adjust your income tax for you, taking into consideration various tax deduction items. So as an employee, you need to report on these papers your tax situation to your employer, such as your dependents and their estimated income, your life or earthquake insurance payment, mortgage interest etc. If you skip the procedures, or if you guit a job in the middle of the year, or in some other cases, you need to file a final tax return by yourself by March 15 next year.



You may be given three kinds of application forms; (1) one for dependent exemption, (2) one for one spouse exemption and (3) one for insurance premium exemption. Note that when you claim a dependent tax exemption for your overseas relatives, you need to attach documents to prove family relationships (such as birth certificates with translation) and records of remittance (more than 380,000 yen must be sent in case of dependents aged 30 to 69) issued by a financial institution.

These are very complicated forms. The Information Desk for Foreign Residents is happy to help you complete these forms. Bring the certificates of payments or other relevant documents.
